Column Headings:

Note: Each column has 2 sub columns, one for the Member, and the other for the member's spouse or partner.

Column 1: Employment, Office, Trade, Profession or vocation (Any employment, office, trade, profession or vocation carried on for profit or gain)

Column 2: Sponsorship (Any payment or provision of any other financial benefit (other than from the Council named above) made or provided within the period of 12 months ending today in respect of any expenses incurred by me in carrying out duties as a member, or towards my election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.)

Column 3: Contracts. (Any contract made between me or my spouse or partner, or a firm in which either of us is a partner, or a body corporate of which either of us is a director, or a body in the securities of which either of us has a beneficial interest, and the Council named above (a) under which goods or services are to be provided or works are to be executed, and (b) which has not been fully discharged.

Column 4: Land. (Any beneficial interest in land which is within the area of the Council named above)

Column 5: Licences. (Any licence (alone or jointly with others) to occupy land in the area of the Council named above for a month or longer.)

Column 6: Corporate tenancies. (Any tenancy where (to my knowledge) (a) the landlord is the Council named above; and (b) the tenant is a body in which I or my spouse or partner has a beneficial interest.)

Column 7: Securities. (Any beneficial interest in securities of a body where – (a) that body (to my knowledge) has a place of business or land in the area of the Council named above; and (b) either – (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I or my spouse or partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
